Seller Agreements

- The Buyer agrees to have the dog examined by a licensed veterinarian of your choice, at your expense within 72 hours of receipt of the dog. Proof of initial wellness examination must be provided to Seller after the initial vet visit. This guarantee will be terminated immediately if the dog is not examined within the allotted time.
- The puppy/dog is healthy at the time of sale and has had immunizations enumerated in the attached health record.
- If the veterinarian determines the puppy to be in ill health with a life threatening illness or genetic defect proven by diagnostic testing the Buyer must notify the Seller immediately. Upon a signed written diagnosis from said licensed veterinarian, the puppy may be returned if this is agreeable to both parties. Buyer will have a choice of either a replacement puppy of equal value from a future litter or full refund of the purchase price not including shipping and medical fees. The Seller will not be responsible for any veterinarian/medical costs at any time which include but not limited to common conditions that are considered minor or correctable such as hernias, infections, parasites, coccidiosis, giardia, cherry eye, viral illnesses or improper bites. Seller does not accept responsibility for contagious diseases diagnosed after 3 days from date of receipt of the puppy. It also does not include any illness due to the ingestion of foreign objects or chemicals.
- If at any time the buyer is unable to keep or care for the puppy/dog, it must be returned to the seller. The puppy/dog may not be transferred or sold by the buyer. The buyer's understanding and acceptance of this condition is signified here by his or her initials: ______ on

_____(date)_____. The seller will endeavor to place any returned puppy/dog as advantageously as possible. If a purchase price is obtained for the puppy/dog, it will be refunded to the original buyer, less any costs of placement. If the puppy/dog is placed free of charge, no money will be returned to the original buyer. No veterinary or other costs of keeping the puppy/dog, or any other costs incurred by the buyer resulting from his/her ownership of the puppy/dog, will be paid by the seller to the original buyer of the puppy/dog under any circumstances

- If the seller determines, by any means, that the puppy/dog is not suitably cared for, or that it has been mentally or physically mistreated, the seller has the right to take full possession of the dog, and its duly signed transfer papers/registration, without compensation.
- The seller's opinion is the only authority required to justify this action. Testimony of other people will not supersede the seller's judgment on this matter. Under such circumstances, all warranties are then VOID.
- No other warranties or guarantees, expressed or implied, are made under this contract except as stated above.

- Permanent ownership of this dog is contingent upon your compliance with this Addendum. The Breeder must receive proof of the spay/neuter procedure having been performed no later than the female becoming 15 months and the male puppy becoming 20 months of age. Proof must be received within fourteen (14) days after completion of the surgery. This notice can be in the form of a Certificate of Spay/Neuter or an invoice from the veterinarian showing the procedure has been completed. In the event the dog's health does not allow this agreement to be honored, Breeder must be provided with a statement from your veterinarian that this dog is not yet in physical or emotional condition for surgery. Based upon the veterinarian's evaluation of this dog the Buyer will contact the veterinarian and establish the earliest date that the procedure can be performed. The Buyer will notify the Breeder of this amendment in writing, at which time all other conditions of this contract will apply and be enforced.
- It is the responsibility of the Buyer, not the veterinarian, to ensure that the Breeder has received verification that the surgery has been performed. Failure to comply with this contract by the date below, unless otherwise agreed to in writing, will be considered a breach of the Contract. The Purchaser will be liable for the price of puppy or the return of the puppy. In addition, it will result in the Health Guarantee being null and void.
- By signing below, I the Buyer agree to have this dog spayed/neutered by no later than
 ______, and I understand that this contract is an agreement that this dog will not
 produce a litter of puppies either as purposely bred or by accidental breeding. If a pregnancy
 occurs whether purposely or accidentally, the Buyer agrees to pay the additional cost for a
 breeding dog, which is \$5,000.
- Buyer commits and understands to training of the puppy and agrees that without training the puppy will not be able to serve as the best companion that it can be.
- Buyer and seller agree to ongoing communication and both parties will notify the other of any changes of address, email or phone number. Buyer agrees to maintain contact with Breeder regarding the puppy/dog at least once per calendar year and to reply as promptly as possible to inquiries regarding puppy/dog. Breeder will be made aware of any change of health in the puppy/dog including but limited to cancer, epilepsy, heart, eye or hearing issues, allergies, bleeding disorders, autoimmune disease and any behavioral issues. If death should occur from natural or accidental death the buyer will notify the breeder.
- BB Doodles guarantees to you that the original purchaser (hereafter you, your puppy) a puppy in good health at the time of sale. This puppy is sold as suitable for a pet and no guarantee is made for show or breeding quality. The guarantee is provided for the protection of BB Doodles and you, but is primarily for the benefit of the puppy. Your puppy has been vet checked and is up to date on shots and worming as noted on the attached form. It is your responsibility to continue to care for this puppy. You must continue the vaccination and worming schedule and not expose your puppy to other dogs that have not been vaccinated until your puppy has completed their initial vaccination schedule at 12-16 weeks. Parvo is a very serious disease and highly contagious. Walking in highly populated dog areas including dog parks should also be avoided until vaccinations are completed. Rabies are recommended by most vets at 5 months of age. Your puppy must be checked by a licensed veterinarian within 72 hours of receiving the puppy, excluding weekends & holidays. If your vet finds the puppy unhealthy for purchase, BB Doodles must be notified immediately in writing by your vet, and subject to verification of the health issue by BB Doodles vet, we will replace your puppy with another of like value when one becomes available

or refund your purchase price. BB Doodles guarantees to you that this puppy is free of from congenital defects until the age of 24 months. If a vet determines your puppy has a hereditary or congenital defect that prevents it from leading a normal life, your vet must notify BB Doodles in writing within 24 hours, and subject to verification by our vet, we will replace your puppy by crediting your purchase price towards the purchase of another puppy from BB Doodles or offer reasonable treatment at our vet at no cost to you, up to the original purchase price of the puppy.
